These products also have been tested in accordance with ANSI/BIFMA Standard Method M7.1-2011 and comply with ANSI/BIFMA e3-2011 Furniture Sustainability Standard, Sections 7.6.1 and 7.6.2. Versteel Product Selection Guidelines

To conform to the Health Care Without Harm's Healthy Interior criteria, v2.3, product and option selections must meet the following recommendations:

Formaldehyde

Versteel furniture that is Intertec Clean Air Certified SILVER and GOLD complies with formaldehyde requirements. There are exceptions, such as the use of wood finishes on certain products. Certificates are available upon request.

Per- and Poly-fluorinated Alkyl Substances (PFAS)

Versteel can assist in the selection of PFAS-free fabrics. For COM fabrics, the customer is responsible for ensuring requirements are met.

Polyvinyl Chloride (PVC)

Versteel offers PVC-free alternatives for edge-banded tops, including polypropylene (PP), Acrylonitrile Butadiene Styrene (ABS), and various wood edges. Availability may be limited and/or require minimum purchase quantities.

While we offer the alternative banding options, PVC edge banding typically makes up less than 1% of the total content, by weight, of Versteel tables and could still meet Healthy Interiors requirements.

Antimicrobials

Versteel furniture and standard carded fabrics do not incorporate antimicrobial chemicals. Customers must specify no antimicrobials for graded-in fabrics. Customers are responsible for COM fabric contents.

Flame Retardants

Versteel standard carded fabrics contain no added flame retardants and therefore comply with this requirement. For graded-in fabrics, Versteel maintains a database of over 2,000 fabric patterns from various manufacturers that contain no flame retardant chemicals, and we can assist in the selection of fabrics that comply. For COM fabrics, the customer is responsible for ensuring the proper fabric content.
